- Move to online public files allows for remote File Inspection
- Reasons for FCC to approve revised ABIP Program Agreement

- Last minute information regarding Senator Ron Paul's concern about provisions of the Pirate Radio Bill affecting the process of the revised agreement being accepted by the FCC
- Participation in the ABIP program is down nationwide
- Major revision of ABIP program could have a devastating effect
- Radio License Renewal will be completed by the end of 2019
 - This is a major "stick" to generate station compliance and to expect last minute surge in request for ABIP Inspections

<u>EAS Committee Report</u>- Suzanne Goucher (Maine) The IPAWS subcommittee of the FEMA National Advisory Committee has wrapped up its work. The recommendations incorporate many of the things we advocated for as we worked through the IPAWS authorizing legislation. Now it's up to FEMA to work through the short-, medium-, and long-term goals set forth. On a personal note, our long-time friend, Greg Cooke, is moving over to the Intergovernmental Office at the FCC as of April 1. There are new contacts for approval of state plans. A replacement for Greg is TBD.

PEP Committee Report-Mark Gordon (Missouri) presented:

- The TMD Group is a small ad agency that promotes opportunities for women in business and has been working with the Wisconsin Air Guard. TMD Group would like to partner with a broadcaster on a proprietary digital product and would like to sign an NDA. Broadcasters know of our program and have no interest in competing. Further conversation pending.
- NRA Gun Safety-Mr. Gordon emailed two contacts and will follow up with a phone call. The programs would be Eddie Eagle (children find a gun) and School Shield (protect our children in school, Oliver North)
- Veteran Suicide Prevention-Progress being made on determining contacts in VA
- FEMA-Conversation with them last week. Remains pending.
- <u>National Excavation Institute</u>-National Call Before You Dig TV Campaign. This would run from March through October. Pending.

Critical Issues Fund (CIF) Committee Report –Chris Merritt (Ohio)

The Critical Issues Fund Committee Report was emailed to the membership on February 19, 2019. Hard copies were also available at the meeting.

NASBA, then BEDA, created the Critical Issues Fund by the vote of the membership in 1996. The Critical Issues Fund (CIF) was set up for the purpose of providing aid in matters that potentially affect all State Broadcasters Associations and their members in circumstances where there is little or no potential for individual State Associations to raise outside funds. The CIF Guidelines document governs its activities.

The intent is to maintain the CIF at a level of \$75,000. When the balance falls below \$75,000, the CIF Committee may ask states to contribute to the fund, using categories (small, medium and large) based upon operating expenses. As of December 31, 2018, the CIF balance was \$75,291.50.

The CIF Committee did not receive any requests for funding in 2018. In January 2019, the Committee unanimously elected Jordan Walton of Massachusetts as the new CIF Committee chair, replacing Christine Merritt of Ohio. Below is the slate of candidates recommended by the CIF Committee for election to a three-year term ending in 2022. These candidates will replace departing Committee members – Lori Needham, Justin Sasso and Christine Merritt.
